An act to repeal and add Section 1353.8 of the Civil Code, relating to common interest developments.

LEGISLATIVE COUNSEL'S DIGEST

AB 1061, as amended, Lieu. Common interest developments: water-efficient landscapes.

Existing law requires a local agency to adopt a specified updated model ordinance regarding water-efficient landscapes or a water-efficient landscape ordinance that is at least as effective in conserving water as the updated model ordinance. Existing law allows certain water providers to take specified actions regarding water conservation.

The Davis-Stirling Common Interest Development Act provides for the creation and regulation of common interest developments. The act provides that the architectural guidelines of a common interest development shall not prohibit or include conditions that have the effect of prohibiting the use of low water-using plants as a group.

This bill would, instead, provide that a provision of any of the governing documents of a common interest development shall be void

and unenforceable if it prohibits, or includes conditions that have the effect of prohibiting, the use of low water-using plants as a group, or has the effect of prohibiting or restricting compliance with a local water-efficient landscape ordinance or water conservation measure described above.

*The people of the State of California do enact as follows:*

- 1 SECTION 1. The Legislature finds and declares all of the  
2 following:
- 3 (a) Landscapes are essential to the quality of life in California,  
4 and are an important aesthetic element with economic value in  
5 common interest developments.
- 6 (b) According to the California Association of Community  
7 Managers, the 2007 California Community Association Statistics  
8 indicate that approximately 11 million Californians, which is nearly  
9 33 percent of the state's population, live in common interest  
10 developments.
- 11 (c) Landscape design, installation, maintenance, and  
12 management can and should be water efficient. The use of  
13 water-efficient landscapes contributes to the state's efforts to  
14 increase the reliability of its water supplies.
- 15 (d) There are common interest developments with governing  
16 documents that hinder or preclude property owners from complying  
17 with applicable water conservation requirements.
- 18 (e) It is in the public interest to ensure that property owners  
19 within a common interest development comply with applicable  
20 state and local ordinances and regulations regarding water  
21 conservation and drought, while maintaining the inherent powers  
22 of a common interest development to establish uniform ~~and~~  
23 ~~acceptable~~ architectural and landscaping standards.
- 24 (f) It is also in the public interest to ensure that property owners  
25 within a common interest development may comply with  
26 emergency water use regulations adopted by authorized providers  
27 of public water supply.
- 28 SEC. 2. Section 1353.8 of the Civil Code is repealed.
- 29 SEC. 3. Section 1353.8 is added to the Civil Code, to read:

- 1 1353.8. Notwithstanding any other law, a provision of any of  
2 the governing documents of a common interest development shall  
3 be void and unenforceable if it does any of the following:
- 4 (a) Prohibits, or includes conditions that have the effect of  
5 prohibiting, the use of low water-using plants as a group.
  - 6 (b) Has the effect of prohibiting or restricting compliance with  
7 either of the following:
    - 8 (1) A water-efficient landscape ordinance adopted or in effect  
9 pursuant to subdivision (c) of Section 65595 of the Government  
10 Code.
    - 11 (2) Any regulation or restriction on the use of water adopted  
12 pursuant to Section 353 or 375 of the Water Code.
